I, _____, for and in consideration of my child, _____, being admitted as a student at Grace Christian Academy, do hereby accept such admission and the duties and responsibilities entailed therein and agree to be bound by the terms of this agreement:

1. I subscribed without reservation to the Articles of Faith and the Standards of Conduct of GCA and agree that my family will abide by these doctrines in all aspects of our live both at and away from school ministries and functions.
2. I have read and understand the Parent/Student Handbook and agree with it completely. I agree that my child(ren) and I must abide by all of the policies, rules, and regulations of GCA, including those listed in the Parent/Student Handbook, and I further agree to support GCA with my conduct and prayers.
3. In order to preserve the spiritual atmosphere nurtured at GCA, I understand that discipline will be more swiftly and rigorously enforced than in a public school environment or in some other private schools. I further understand there may be times where I disagree with the discipline imposed upon my child. I further understand that in the event of such disagreement, I am to request a conference with the principal.
4. I understand GCA, in the interest of nurturing its school atmosphere and spiritual goals, has a "Zero Tolerance" policy regarding possession and /or use of drugs on or off campus.
5. I understand and agree that attending GCA is a privilege and the school reserves the right to suspend
6. I agree to fully cooperate with GCA's administration regarding all actions requested of me pertaining to my child's or children's enrollment at the school and in the enforcement of its rules and policies. I agree to uphold the aims and ideals of the school and to encourage my child(ren) to likewise abide by the aims and ideals of the school.
7. I understand that my child's or children have continued enrollment at GCA is conditioned upon my prompt and timely payment of all tuition and fees (including late fees).
8. I, as a student of GCA, agree to abide by the rules, policies, and procedures and to uphold the aims and ideals of the school as stated in the Parent-Student handbook.
9. I understand and agree that my child has no right to publish and/or distribute flyers, literature, posters or other publications and that GCA has the right to control what is published, circulated, or otherwise distributed at school to its students or staff, and I will ensure that my child understands this provision.

As GCA is a Christian ministry organization, both parties agree that they would never make demands, threaten to sue, or actually litigate any matter whatsoever relating to or resulting from this agreement. Such clearly violate Biblical teaching and shall constitute immediate grounds for withdrawal of all of my child(ren) from enrollment at GCA. I understand that retaining or instructing an attorney to contact the ministry with regard to a potential claim or dispute will be interrupted as a threat to sue.
11. I agree that is my child(ren) damage or destroy school property, I will be financially accountable for the repairs and/or replacement.
12. I agree to attend the three required meetings which are Orientation (August), Parent Teacher Fellowship (January), and annual awards ceremony (May).
13. I certify that I will explain this agreement and its meaning to my child(ren). I will assist the school in every way necessary to ensure my child abides by all the terms of this agreement.
